[A Guide for Integrating Human Rights into Business Management by OHCHR](#)

That this publication is a joint product of the Business Leaders Initiative on Human Rights (BLIHR), the United Nations Global Compact Office, and the Office of the High Commissioner for Human Rights (OHCHR), and it offers practical guidance to companies that want to take a proactive approach to human rights within their business operations. It is principally for business leaders and managers in large and medium-sized enterprises, private and state-owned, who would like to develop their understanding of human rights in business practice. BLIHR is a business-led program that is developing practical tools and methodologies for applying human rights principles and standards across a range of business sectors, issues, and geographical locations. The ten member companies of BLIHR took the lead in this Guide's development, in which they share some of their experiences and lessons they have learned.

This Guide is based on a conventional management system. It follows the Global Compact Performance Model, which is a map for responsible corporate citizenship. The model allows business to implement the Global Compact principles without undermining their other business goals. The Performance Model was built on practical experience, identifying methods that actual companies followed to mainstream the Global Compact principles into their own business operations and activities.

This guide is intended to be a technical manual and a hands-on toolkit to help any company integrate practices consistent with human rights standards into an existing management system. It is made up of seven elements common to most management systems: Strategy, Policy, Processes and Procedure, Communications, Training, Measuring Impact and Auditing, and Reporting. The Getting Started section identifies the initial steps a company should take to implement the performance model, and in the appendices at the end of the Guide authors list tools and resources which the BLIHR companies have found to be helpful in bringing human rights into their businesses.

Furthermore, the examples in this guide illustrate how aspects of the model have been implemented and are designed to inspire other businesses. The human rights processes and procedures included in this guide are ongoing projects for the companies concerned.

[The Right to Water by WHO](#)

Safe drinking water and sanitation are indispensable to sustain life and health, and fundamental to the dignity of all. Yet, 884 million people do not have access to improved sources of drinking water, while 2.5 billion lack access to improved sanitation facilities. While these numbers shed light on a worrying situation, the reality is much worse, as millions of poor people living in informal settlements are simply missing from national statistics.

For that reason, WHO issued a fact sheet on the Right to Water. This fact sheet explains what the right to water is, illustrates what it means for specific individuals and groups, and then elaborates upon state obligations with respect to that right. It concludes with an overview of national, regional and international accountability and monitoring mechanisms.
